Maritime Mobile Service

Singapore

Communication of 19.II.2001:

Infocomm Development Authority of Singapore (IDA) announces that, as from 31 March 2001, at 2359 hours (local time) or 1559 hours (UTC), the Maritime and Port Authority of Singapore (MPA) will cease to monitor and receive distress alerts and messages from ships on the following GMDSS frequencies: 2187.5 kHz (DSC), 2182 kHz (RT) and 2174.5 kHz (NBDP).

MPA will continue to monitor for distress messages and alerts from ships on VHF (channel 16) and VHF DSC (channel 70). MPA will continue to receive distress alerts through the COSPAS-SARSAT ground station and Inmarsat services. In addition, MPA will continue to broadcast Maritime Safety Information (MSI) on VHF (channel 09), NAVTEX and Inmarsat's enhanced group calling (EGC) SafetyNET.

Change in working hours of the international telegram service

Telenor Telecom Solutions a.s., Maritim Radio (Rogaland Radio), Sandnes, announces that as from 1 May 2001, the international telegram service in Norway only will operate weekdays from Monday to Thursday, from 0600 hours to 1900 hours UTC, (summer-time 0500 hours to 1800 hours UTC) and Friday, from 0600 hours to 1430 hours UTC (summer-time 0500 hours to 1330 hours UTC).

Notification of the end of parallel running of the previously used country code +41 75 for Liechtenstein

The Office for Communications (regulatory body) in Liechtenstein, Vaduz, announces that as from 12 April 2001, all calls to Liechtenstein using the former country code +41 75 followed by the subscriber number will be routed to an announcement (without onward routing).

Consequently, as from this date, telephone users can call Liechtenstein only by dialling +423 followed by the subscriber number (no area code).

Telecommunication administrations and recognized operating agencies (ROAs) are requested to take all measures necessary to ensure that the country code +423 for Liechtenstein is opened in their switches and therefore accessible for telephone users via all routing choices (please find test call numbers below).

In a transitional phase from 2 October 2000 until 12 April 2001, all calls to Liechtenstein using the old country code +41 followed by the area code 75 and the subscriber number will be routed to an announcement with onward routing of the call after the end of the message. There will be no more onward routing after that point in time.
